# **Academic Integrity**

#### Definition

Academic integrity (also called academic honesty) means that you will be honest in your own academic work and report any violations of the honor code by other colleagues.

# Cheating

#### **Definition**

Cheating is taking or giving any information or material which will be used to determine academic credit.

- Create non-existing data
- Modify the existing data
- Use a subset of all obtained data

## Cheating Example

#### Jan Hendrik Schön

- Researcher at Bell Labs working in the field of condensed matter physics and nanotechnology
- In 2001, he was listed as an author on an average of one research paper every eight days
- Claimed to have produced a transistor on the molecular scale
- Published (and peer reviewed) papers were suspected to contain duplicated and anomalous data
- He was dismissed after an investigation found 24 cases of misconduct
- Science withdrew 8 papers and Nature 7 papers co-authored by Schön

## Cheating Example

## Haruko Obokata (小保方晴子)

- A former stem-cell biologist and research unit leader at Japan's Laboratory for Cellular Reprogramming, Riken Center for Developmental Biology.
- She claimed to have developed a radical and remarkably easy way to generate stimulus-triggered acquisition of pluripotency (STAP) cells that could be grown into tissue for use anywhere in the body.
- In response to allegations of irregularities in Obokata's research publications involving STAP cells, Riken launched an investigation that discovered examples of scientific misconduct on the part of Obokata.
- Attempts to replicate Obotaka's STAP cell results failed. The ensuing STAP cell scandal gained worldwide attention.
- Her advisor Satoshi Tsuneda was found dead at Riken from an apparent suicide.
- Her Ph. D. degree is withdrawn.

## Cheating Example

## Chen-Yuan Chen (陳震遠)

- A professor at National Pingtung University (國立屏東大學)
- He published 60 papers in Journal of Vibration and Control.
- Editor Ali H. Nayfeh reviewed Chen's paper and found 130 dummy accounts that all belonged to Chen.
- Chen resigned from NPTU and the papers are withdrawn.
- Chen's brother is also involved in some of the papers.
- Minister of Education is the advisor of Chen's brother and he was listed as an author in some of the papers, he resigned from Ministry of Education.

# **Plagiarism**

#### Definition

Plagiarism is the act of using another person's words or ideas without giving credit to that person

- Rewrite the sentence (using different wording and structures) without citation
- Rewrite the sentence (using different wording and structures) with citation

## Self-Plagiarism

### **Definition**

Self-plagiarism is defined as a type of plagiarism in which the writer republishes a work in its entirety or reuses portions of a previously written text while authoring a new work.
